

“LUNCH ON FARMER’S FRIDGE GIVEAWAY” SWEEPSTAKES

OFFICIAL RULES

1. HOW TO ENTER: NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A purchase will not increase your chances of winning. The “Lunch On Farmer’s Fridge Giveaway” Sweepstakes (the “Sweepstakes”) is being organized by Romaine Empire, Inc. (d/b/a Farmer’s Fridge) (“Sponsor”). The Sweepstakes will run beginning at 5:00 PM EST and ending at 7:00 PM EST on Thursday, April 11, 2019 (the “Sweepstakes Period”). Enter the sweepstakes by (i.) downloading the Farmer’s Fridge app on a mobile device and (ii.) providing your contact information (a) at a Sponsor related event (via a business card or by filling out a contact information card provided by Sponsor) or (b) by emailing sweepstakes@farmersfridge.com. All entrants must have a valid email address. Limit of one (1) entry per person per Sweepstakes Period.

Entrants may not enter with multiple email addresses, business cards, or contact information cards. Any entrant who attempts to enter with multiple business cards, contact information cards, or email addresses under multiple identities or uses any device or artifice to register multiple times will be disqualified and forfeits any prize won, in Sponsor’s discretion. Should multiple users of the same email account enter the Sweepstakes and a dispute thereafter arise regarding the identity of the entrant, the authorized account holder of said email account at the time of entry will be considered the entrant. “Authorized account holder” is defined as the natural person who is assigned an email address by an Internet access provider, online service provider or other organization which is responsible for assigning email addresses or the domain associated with the submitted email address. Sponsor reserves the right at its sole discretion, to disqualify any individual (and all of his or her entries) who tampers with the entry process. Automated entries are prohibited, and any use of automated devices will cause disqualification.

Sponsor and affiliates are not responsible for late, lost, delayed, unclear, incomplete, misdirected, or ineligible entries which will be disqualified or for technical, hardware, or software malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications caused by the sender, or by any of the equipment or programming associated with or utilized in the Sweepstakes which may limit the ability to play or participate, or by any human error that may occur in the processing of the entries in the Sweepstakes. The computer clock of Sponsor is the official timekeeping device of the Sweepstakes.

2. ELIGIBILITY: The Sweepstakes is open to legal residents of Indiana aged 18 years or older except employees of, Sponsor and affiliated companies, advertising agencies, and promotional partners, and relatives of and those living in the same household as such employees. For the purpose of this Sweepstakes, relatives are defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children

and grandchildren. All federal, state and local laws and regulations apply. Void where prohibited.

3. SELECTION OF WINNERS: On or about April 11, 2019, Sponsor or its designated judges (whose decisions are final) will conduct a random drawing among all eligible entries to determine three (3) prize winners. The winners will be notified that they may have won a prize in this Sweepstakes by phone or email on or about April 11, 2019. Any winner who does not provide a valid email address or phone number will forfeit his/her prize. If any prize notification, prize, or Sweepstakes communication is rejected or returned as undeliverable or if a winner cannot be reached after a reasonable attempt has been made by Sponsor (as determined by Sponsor in its sole discretion), such winner may be disqualified and an alternate winner may be selected from all eligible entries. Upon prize forfeiture, no compensation will be given.

4. PRIZES/ODDS: There will be three (3) prizes (the "Prizes") awarded, consisting of (i.) thirty (30) one-time use \$10 codes, (ii.) seven (7) one-time use \$10 codes, and (iii.), five (5) one-time use \$10 codes. Each code will allow the winners to purchase up to \$10 of products at any Farmer's Fridge smart fridge. Each code only allows the winners to make one purchase, and if the purchase is less than \$10, there is no carry over value. Codes do not need to be used consecutively. Codes will expire on July 1, 2019. Approximate Retail Value of Prizes: \$420.00.

Winners will not receive difference between actual and approximate retail value. Odds of winning depend on number of eligible entries received. Any Prize legitimately claimed will be awarded. No transfers, prize substitutions or cash redemptions will be made, except at Sponsor's sole discretion. The Prize is non-refundable and must be accepted as awarded. No more than the stated number of Prizes will be awarded.

Sponsor will not replace any lost or stolen prize. All state, federal, and local taxes are the sole responsibility of the winner.
